ORDER:

In the G.O 1<sup>st</sup> cited, orders were issued appointing 6 members to  
the Telangana State Commission for Protection of Child Rights.

2. In the G.O 2<sup>nd</sup> cited, orders were issued appointing Sri Gudimalla  
Ravi Kumar as Chairperson to the Telangana State Commission for  
Protection of Child Rights.

3. In the reference 3<sup>rd</sup> cited, the Hon'ble High Court held that  
entire selection procedure for selection of Chairman & Members of State  
Commission for Protection of Child Rights is vitiated since only two  
members have conducted the interviews instead of Committee of three  
(i.e., Minister for WCD&SC + Nominee of Chief Justice of High Court +  
Nominee of Speaker of Legislative Assembly) and all the appointments  
were set aside.

4. After Careful examination of the matter and in order to implement  
the directions of Hon'ble High Court, the appointments of Chairperson  
and Members of the State Commission for Protection of Child Rights  
appointed in the G.Os 1<sup>st</sup> and 2<sup>nd</sup> read above are hereby cancelled.

5. The Director, Women Development & Child Welfare Hyderabad  
shall issue re-notification in leading Newspapers inviting applications  
from eligible persons for appointment of Chairperson and members to  
the Telangana State Commission for Protection of Child Rights and also  
take necessary action accordingly. Any such notification shall be subject  
to outcome of writ appeal pending before Hon'ble High Court in writ  
appeal No.1982/2017.
