#### **TERMS AND CONDITIONS**

#### **RATE**

- Rate should be quoted in figures as well as in words. Telegraphic/ pencil written, over writing, abbreviated and any conditional offers will be rejected.
- All duties, taxes and other levies payable by the bidder on the finished goods shall be included in the quoted rate.
- Telex or facsimile/exact copy of quotations is not acceptable.

#### **VALIDITY OF TENDER**

- Tender shall remain valid for a period not less than 2 months after the deadline date specified for submission.

#### **EARNEST MONEY DEPOSIT (EMD)**

- The **EARNEST MONEY DEPOSIT (EMD)** of Rs.1,40,000/- shall be through Demand Draft from any nationalized bank drawn in favour of **Account Officer, Women Development and child Welfare Department, Telangana, Hyderabad.**
- The EMD will be returned only after finalization of the tender and no interest shall be paid.

## **SECURITY DEPOSIT**

- The successful tenderer shall be required to keep Performance/ Security Deposit @10% on the value of the contract in the shape of Demand Draft/bank Guarantee within 7 working days after receiving the work order for which no interest shall be paid.

## **DELIVERY PERIOD**

- The Bidder shall supply the total number of books within 30 days from the date of placing order along with transportation charges, VAT etc.
- The Director, WD&CW Dept. is having full powers to change the matter and approve the sample book.
- The technical specification will be verified & certified by MSME/ SSI certified registered company.

## **DELIVERY OF MATERIAL**

- The successful tenderer should deliver the material at the points as specified in the work order within 30 days from the date of issuing distribution order.
- All the material should be packed properly stitched and the material should not be exposed or damaged.
- For the delay delivery, penalty @1% of the total amount of the bill is imposed for each day of delay after the due date. The Director, WD&CW Dept., Telangana, Hyderabad has full powers either to accept the executed with late penalty or to cancel the order without any further notice and for it the EMD and Security Deposit or issue any other order keeping in view the facts and circumstances.



## **PAYMENTS**

- The Successful tenderer should submit the bills in triplicate along with advanced stamped receipt immediately after completion of the supply. Payment will be made to the firm after completion of official procedure.
- No interest is to be paid on the amounts paid towards EMD or Security Deposit.

## **OTHER CONDITIONS**

- **Pre-qualification, Technical and Financial bids have to be made in separate sealed covers as the financial bids of only technically qualified tenders will be opened.**
- The bids would be evaluated for books.
- Tenders received after due date and time will not be accepted. No correspondence will be entertained in this regard.
- Income Tax shall be deducted at applicable rates from the bills under Section 194(c) of the Income Tax Act, 1961.
- In case the successful tenderer fails to deliver the material within the prescribed period, the firm is liable to make good of the loss sustained by the Department in addition to Security Deposit and the firm will be kept under Block list and they will not be considered for participation in Tenders in future.
- The Director, Women Development and Child Welfare Department, Telangana, Hyderabad reserves the right to increase or decrease the quantity and reject any or all the tenders even after award of work if they fail to fulfill the conditions and specifications and the work may be entrusted to the next tenderer deemed fit and recover the loss caused from the defaulter.
