ORDER :

In the G.O.2nd read above, the Government orders are hereby issued notifying District Collector/District Magistrate as a District Officer for every District to exercise powers and discharge functions under the Sexual Harassment of Women at Workplace (Prevention, prohibition and Redressal) Act,2013 and as per the Sub-section 1 of the Section 6, the District Officer shall constitute in the district concerned, a committee to be known as the 'Local Complaints Committee' to receive complaints of sexual harassment from establishments where the Internal Complaints Committee has not been constituted due to having less than ten workers or if the complaint is against the employer himself and requested to notify District Officer in all the Districts of Telangana State as per the Act for the prevention and redressal of complaints of sexual harassment.

The "Local Complaints Committee" has been constituted for receiving complaints of sexual harassment as per the Act for the prevention and redressal of complaints of sexual harassment. The following are the members constituting the "Local Complaints Committee" for receiving complaints of sexual harassment

1. Chairperson - Smt.Saritha, District Co-ordinator, Adilabad
2. Member - Kum.Sravani, CDPO, ICDS Project Utnoor.
3. Member -
 - a. Smt.Manjulatha, Lawyer.
 - b. Smt.Sumithra, SHG Member.
 - c. Smt.Smt.Udaysree, Sectoral Officer, O/o DEO, Adilabad
4. Ex-officio members – Smt.K.Milkah, District Welfare Officer, WCD&SC, Adilabad.

The Chairperson and every Member of the "Local Complaints Committee" shall hold office for such period, not exceeding three years, from the date of their appointment.

The Chairperson or any Member of the Local Complaints Committee, as the case may be, shall be removed from the Committee and the vacancy so created or any casual vacancy shall be filled by fresh nominations in accordance with the provisions of this section as per Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013

The District Welfare Officer, Women, Children, Disabled & Senior Citizens, Adilabad shall take necessary action accordingly.
