#### ORDER:

In the G.O. 2<sup>nd</sup> read above, the Selection Committee has been constituted under the Chairmanship of Dr.Justice Motilal B.Naik Judge (Retired), High Court, Hyderabad for selection of Chairperson/Members of Child Welfare Committees and Social Workers of Juvenile Justice Boards as required under Rule 87 of Model Rules, 2016 under JJ(CPC) Act, 2015. The Selection Committee has submitted its recommendations to Government based on the process laid down as per rule 88(4) of JJ Modal Rules, 2016.

- 2. Government after careful examination of the said recommendation and in order to implement the provisions of the Juvenile Justice (CPC) Act, 2015 hereby constitutes the Child Welfare Committee for the Districts in the State with respective district as their jurisdiction.
- 3. Accordingly, the following Notification shall be published in the Extraordinary issue of the Telangana State Gazette on 05.02.2021:

#### **NOTIFICATION**

In exercise of the powers conferred under sub-section 1 of Section 27 of Juvenile Justice (CPC) Act, 2015 (Central Act 2 of 2016), Government hereby constitutes the Child Welfare Committee for Medchal-Malkajgiri District as mentioned in the table below for a period of (3) years from the date of issue of notification for exercising the powers and to discharge the duties conferred on such Committee in relation to children in need of care and protection under the Act.

4. The Chairperson and Members of existing Child Welfare Committees shall hand over the records and other material to the District Welfare Officer of the erstwhile District concerned. The District Welfare Officer, WCD & SC shall monitor and submit compliance report to the Government.

- 5. The Commissioner, Women Development and Child Welfare Department, Hyderabad shall provide induction training and sensitisation to the Chairperson and Members of Child Welfare Committees within two months from the date of notification.
- 6. The Commissioner, Women Development and Child Welfare Department shall take necessary action accordingly.
