ORDER:

- 2. The Government after careful examination of the said recommendation and in order to implement the provisions of the Juvenile Justice (CPC) Act, 2015 hereby appoints the Social Worker members the Juvenile Justice Board, Adilabad.
- 3. Accordingly, the following Notification shall be published in the Extraordinary issue of the Telangana State Gazette on 17.02.2021:

NOTIFICATION

In exercise of the powers conferred under sub-Section 1 of Section 4 of Juvenile Justice (CPC) Act, 2015 (Central Act 2 of 2016), Government hereby appoints the Social Worker members the Juvenile Justice Board for District as mentioned below for exercising the powers and discharging its functions relating to children in conflict with law under the Act.

The Commissioner, Women Development and Child Welfare Department, Hyderabad shall provide induction training and sensitisation on care, protection, rehabilitation, legal provisions and justice for children to the Social Worker Members of Juvenile Justice Boards within two months from the date of notification.
