ORDER:

In the G.O. 2nd read above, the Selection Committee has been constituted under the Chairmanship of Dr. Justice. Motilal. B. Naik Judge (Retired), High Court, Hyderabad for selection of Chairperson/Members of Child Welfare Committees and Social Workers of Juvenile Justice Boards as required under Rule 87 of Model Rules, 2016 under JJ (CPC) Act, 2015. The Selection Committee has submitted its recommendations to Government based on the process laid down as per Rule 88(4) of JJ Model Rules, 2016.

- 2. The Government after careful examination of the said recommendation and in order to implement the provisions of the Juvenile Justice (CPC) Act, 2015 hereby appoints the Social Worker members the Juvenile Justice Board, Khammam.
- 3. Accordingly, the following Notification shall be published in the Extraordinary issue of the Telangana State Gazette on 17.02.2021:

NOTIFICATION

In exercise of the powers conferred under sub-Section 1 of Section 4 of Juvenile Justice (CPC) Act, 2015 (Central Act 2 of 2016), Government hereby appoints the Social Worker members the Juvenile Justice Boards for District as mentioned below for exercising the powers and discharging its functions relating to children in conflict with law under the Act.

The Commissioner, Women Development and Child Welfare Department, Hyderabad shall provide induction training and sensitisation on care, protection, rehabilitation, legal provisions and justice for children to the Social Worker Members of Juvenile Justice Boards within two months from the date of notification.

5. The Commissioner, Women Development and Child Welfare Department shall take necessary action accordingly.
